Agenda Item 1 – Welcome & Introductions

Chairperson Larry deGhetaldi called the meeting to order, reviewing housekeeping notes for attendees and Board members.

Agenda Item 2 – Transcript from August 10, 2022 FSSB Meeting (Transcript, P. 8)

Dr. deGhetaldi asked if there were any changes to the August 10, 2022, FSSB meeting transcript and summary. Motion to approve the transcript by Paul Durr, seconded by Scott Coffin. The Board approved the August 10, 2022 transcript.

Agenda Item 3 – Director's Remarks

Director Mary Watanabe announced that it would be last meeting for Dr. Ted Mazer and thanked him for his service to the Board. Ms. Watanabe provided an update on the Health Equity and Quality Committee and regulations that are in the rulemaking process.

Ms. Watanabe announced that with Dr. Mazer's exit from the Board, the DMHC will release a solicitation looking for applicants to participate as a Board Member. The new Board Member will join the FSSB in February 2023.
