

Summary of Plan Performance

Purpose: The focus of the Health Equity and Quality Committee is to address disparities and enable an equitable health care delivery system statewide. The purpose of this document is to draw attention to the number of plans that would be required to improve on recommended measures based on a benchmark floor and bringing all plans to a minimum standard level of care, as recommended by the Committee. For example, for the Well-Child Visits in the First 30 Months of Life (W30) – First 15 Months measure, 7 of 16 plans are currently at or above the Commercial 25th percentile. 9 plans would be required to improve on current performance to meet the Commercial 25th percentile. Numbers in red indicate measures where enforcement action may be required of plan(s).
