Agenda Item 1 – Welcome and Introductions

Sarah Brooks, Project Director, called the meeting to order, conducted a roll call, gave an overview of the fourth Committee meeting, walked through the agenda, meeting materials, and Committee timeline. Janel Myers, Quality SME, reviewed housekeeping notes for in-person and virtual Committee members and members of the public.

Agenda Item 2 – Review of May 18, 2022 Meeting Summary (Transcript, P. 12-13)

Ms. Brooks asked if there were any changes to the May 18, 2022, meeting summary. There were no changes to the May 18, 2022, meeting summary.

Agenda Item 3 – Data Exchange Framework Presentation (Transcript, P. 13-29)

John Ohanian, Chief Data Officer for CalHHS and Director of CDII and Rim Cothren, Independent Health Information Exchange Consultant for CDII, presented on the vision and purpose of the Data Exchange Framework initiative, timeline for implementation, and capabilities as it relates to the work of the Health Equity and Quality Committee.

Agenda Item 4 – Complete Discussion on Measures and Disparities by Focus Area (Transcript, P. 29-88)

Ms. Brooks gave a brief overview of the goal and audience for the measures selected, the process for measure selection, guiding principles, focus areas, and how the measures for the Committee's review and discussion were identified. Ms. Brooks also reviewed the measures identified for further discussion by the Committee during the April 20 and May 18 meetings for the prevention, chronic conditions, mental health, substance use, and birthing persons and children focus areas. Ignatius Bau, Health Equity SME, and Dr. Andy Baskin, MD, Quality SME provided overviews of disparities and measures for the utilization, specialty, appropriateness of care, and patient experience focus areas, respectively.

After a robust discussion, the Committee recommended the measures below for each focus area.

Utilization Focus Area:

Avoidable Emergency Room Visits

Appropriateness of Care Focus Area:

- Transitions of Care: Medication Reconciliation Post-Discharge
- Plan All-Cause Readmissions (PCR)
- Timely Follow-Up After Acute Exacerbations of Chronic Conditions

It was determined further discussion of the Consumer Assessment of Healthcare Providers & Systems (CAHPS) Health Plan Survey is required at the June 22

Committee meeting to discuss the following composite measures to address the specialty, appropriateness of care, and patient experience focus areas:

- Getting Needed Care
 - o Q9. Easy for respondent to get necessary care, tests, or treatment
 - o Q18. Respondent got appointment with specialists as soon as needed
- Getting Care Quickly
 - Q4. Respondent got care for illness/injury as soon as needed
 - o Q6. Respondent got non-urgent appointment as soon as needed

Mr. Bau and Dr. Baskin provided overviews of disparities and measures for the population health focus area, respectively. Mr. Bau separately reviewed the proposed measures for Committee discussion for the health equity focus area. The Committee recommended the measures below for the population health and health equity focus areas.

Population Health Focus Area:

- Adult Immunization Status
- Body Mass Index (BMI) Screening and Follow-Up Plan
- Obesity Prediabetes and Diabetes A1c Control

Health Equity Focus Area:

- Meaningful Access to Health Care Services for Persons with Limited English Proficiency
- Patients Receiving Language Services Supported by Qualified Language Services Providers
- Cultural Competency Implementation Subdomain: Quality improvement

It was also determined the final report will include language recommending the Health Equity Index measure proposed by Dr. Cheryl Damberg and National Committee for Quality Assurance (NCQA) Health Equity Accreditation (HEA).
