# PARENT AND FAMILY SERVICES

### **One-on-One Family Coaching**

A private meeting with a family (including the trans person themselves) to talk about what this next part of their lives might look like. Allows the trans person to define their own identities without the expectation of being the sole educator on trans issues.



# YOUTH SERVICES

Connecting trans and nonbinary youth (up to age 30) with peer-to-peer support, mentorships, social spaces, and more.



### Like Me! Buddy Program

Connects trans and gender diverse elementary schoolers with peers





# YOUTH SERVICES

### **GenderJunk Program**

Helps clients get connected to gender affirming items when they are unable to access them

# YOUTH SERVICES



### **Kyler's Konnections Mentor Program**

Connects folks who are newer to their gender journey with mentors of similar identities and transition goals for support as they navigate life.



# **Holistic Re-entry Services**



#### **The Trans Power Program**

Serves TGI community members who have been formerly incarcerated or impacted by the "war on drugs," specifically with harm reduction, rehabilitation, and mental health as well as workforce development.

Serves TGI community members who have been released from immigration detention centers or county jail facilities.

- Health and Safety Code, Section 1367.043. (a) (2)
- An evidence-based cultural competency training implemented pursuant to paragraph (1) shall include all of the following:
- (A) Information about the effects, including, but not limited to, ongoing personal effects, of historical and contemporary exclusion and oppression of TGI communities.





(B) Information about communicating more effectively across gender identities, including TGI-inclusive terminology, using people's correct names and pronouns, even when they are not reflected in records or legal documents; avoiding language, whether verbal or nonverbal, that demeans, ridicules, or condemns TGI individuals;





• (B) cont.

and avoiding making assumptions about gender identity by using gender-neutral language and avoiding language that presumes all individuals are heterosexual, cisgender or gender conforming, or nonintersex.

• (C) Discussion on health inequities within the TGI community, including family and community acceptance.
