CPEHN has a long history of successfully advancing equity in California's health care systems. We authored reports as early as 2001 and as recently as 2022 on improving health care quality and advancing more equitable health outcomes by holding health plans accountable for performance on consumer assessment surveys and quality measurement in physical, oral, and mental health care. We have advocated successfully for the development of quality and equity performance standards in Covered California and Medi-Cal coverage. We also advocated for Limited English Proficient patients during managed care creation and passed successful language access policies in health care settings. In 2022, CPEHN was invited to serve on DMHC's Health Equity and Quality Committee (HEQC) where we were tasked with making recommendations to the DMHC Director for standard health equity and quality measures. In our role we provided input on key topics that will be important to assessing compliance with statewide quality/equity goals including: Annual benchmark standards for public and commercial insurance; Minimum demographic data collection and reporting standards that particularly encourage self-reported data by race, ethnicity, language, sexual orientation and gender identity, disability status and health-related social needs; Adoption of NCQA Accreditation including Health Equity Accreditation; Establishment of a statewide measure set to gauge health plan performance on quality and equity goals; Establishment of a specific statewide measure set to address mental health plan performance on quality and equity goals; Establishment of language assistance measure(s) to gauge health plan performance in meeting California language access laws on interpreter services and written translations.

Unfortunately, the lack of standardized disaggregated collection and release of race and ethnicity data for communities of color, including AANHPIs, has masked health disparities and outcomes and hidden the disproportionate impact on many communities. CPEHN's participation on the HEQC was important to ensure that the initiative has the intended impact and will result in more equitable outcomes for all Californians.
