I contributed to the Health Equity and Quality Committee's (HEQC) proceeding by presenting on the range and evidence of health disparities experienced by people with disabilities. I prepared in advance for each HEQC meeting, and within each meeting asked clarifying questions, raised factual information relevant to agenda topics, and ensured that the viewpoints and needs of the disability community were provided to other voting members, presenters, and DMHC staff. In between meetings, I sent to DHMC staff for distribution to the committee documentation of health equity studies and research on how people with a range of disabilities experience multiple barriers to receiving effective. accessible, and affordable health care. Throughout the HEQC process, I advocated for the full inclusion of people with disabilities, including those who hold intersecting characteristics such as race, ethnicity, older or younger age, limited English proficiency, or LGBTQ+ status, that make them additionally likely to have limited access to social drivers of health. In particular, I argued for the necessity of ensuring that voluntarily provided demographic information about disability status is consistently collected by health care providers, insurers, and state agencies so that measures of health equity and quality could be stratified in ways that recognize the distinct and compounded ways in which disability affects health care accessibility and coverage.

## 5. Clear and concise statement of participants interest in the proceeding which explains why participation is needed to represent the interests of consumers

AB 133 (2021) required DMHC to adopt standard health equity and quality measures that health plans will report on annually to the Department. In doing so, the department was to establish a Health Equity and Quality Committee. Section 14 of the bill added Article 11.9 to the Health and Safety Code and specifically required the Health Equity and Quality Committee to "consider the interaction of multiple patient characteristics in determining where disparate outcomes exist, including but not limited to, race, ethnicity, gender, sexual orientation, language, age, income, and disability." DREDF has long sought the recognition of disability status as a patient characteristic that, like the other listed demographic characteristics, is associated with reduced access to social drivers of health and unique health care barriers, resulting in worsened health outcomes. Disability is not, in our strong and informed opinion, a purely clinical factor inherently associated with ill health. Our participation on the committee allowed us to share our expertise in disability health and health care disparities and argue for quality measures and stratification of measures that could help capture those disparities. Whether congenital or acquired after birth, disabilities and/or chronic conditions intersect with all other patient characteristics. People with disabilities are a highly heterogeneous group. For several years, DREDF has worked at this intersectional edge of "disability plus" because we understand that an individual who lives with multiple personal characteristics and identities can be subject to compounded disparities, not merely additive ones. California still does not collect demographic information regarding disability status across public and private health insurance systems, or even within those distinct systems. However, models in other states exist for doing so, and a commitment to equity should motivate DMHC to require the health plans within its jurisdiction to at least actively prepare for the collection of disability demographic information, with the goal of eventually fully including that information in plan reporting on health equity and quality. The inclusion of disability elements within the latest versions of data interoperability standards of the Office of the National Coordinator for Health Information, and within upcoming EPIC record system "automatic" updates, are promising signs that plans will soon have needed tools to support efforts for collecting voluntary self-disclosed information on disability status. Once that information is acquired, California can begin to stratify equity and quality measures by disability as well as a combination of disability and other factors.
