SUBJECT: APL 22-024 - New and Amended Annual Network Report Forms for Reporting Year 2023, Resulting from SB 221 and AB 457

The Department of Managed Health Care (DMHC) issues this All Plan Letter (APL) to inform health care service plans (health plans) of the new and amended report forms for the reporting year 2023 Annual Network Report submission, based on recent changes to the law.

Background

Health plans are required to submit an Annual Network Report to the DMHC on an annual basis.¹ Required report forms for Annual Network Reporting are incorporated in Rule 1300.67.2.2 (effective April 1, 2022). The field instructions for these forms are within the Timely Access and Annual Network Submission Instruction Manual (Instruction Manual), incorporated in Rule 1300.67.2.2.

The DMHC has added new and amended report forms for the Reporting Year (RY) 2023 Annual Network Report submission, as a result of new law enacted by Senate Bill (SB) 221 (Wiener, Chap. 724, Stats. 2021), and Assembly Bill (AB) 457 (Santiago, Chap. 439, Stats. 2021).² SB 221 provides an exemption from the Administrative

Procedure Act (APA) to develop and adopt reporting methodologies until July 1, 2025.³ AB 457 includes annual requirements for reporting of Third-Party Corporate Telehealth Provider data as part of the Annual Network Report submission.

Required Report Forms for RY 2023 Annual Network Reporting

In accordance with Section 1367.03(f)(3), health plans shall use the following Annual Network Report Forms and accompanying field instructions for RY 2023. All RY 2023 Annual Network Report Forms and instructions are available to health plans on the Resources section of the Timely Access and Annual Network Reporting Web Portal.

RY 2023 New and Amended Annual Network Report Forms:

Attached to this APL are the new and amended final report form fields and field instructions for the listed Annual Network Report Forms.⁴ The final fields and field instructions hereby replace the relevant sections of the Instruction Manual incorporated in Rule 1300.67.2.2, as follows:

- Mental Health Professional and Mental Health Facility Report Form Instructions (Form No. 40-268) (Amended). Replaces Section V.D. of the Instruction Manual for RY 2023.
- 2. Telehealth Report Form Instructions (Form No. 40-271) (Amended). Replaces Section V.G. of the Instruction Manual for RY 2023.
- Third-Party Corporate Telehealth Provider Report Form Instructions (New). Adds Section V.J to the Instruction Manual for RY 2023.⁵

The amended report forms (Form Nos. 40-268 and 40-271, as amended) hereby replace the forms incorporated in Rule 1300.67.2.2. The new Third-Party Corporate Telehealth Provider Report Form is hereby incorporated in Rule 1300.67.2.2 as a standardized methodology for reporting pursuant to Sections 1367.03(f)(3) and 1367.035(a). Fillable versions of these report forms are available in the Web Portal.
