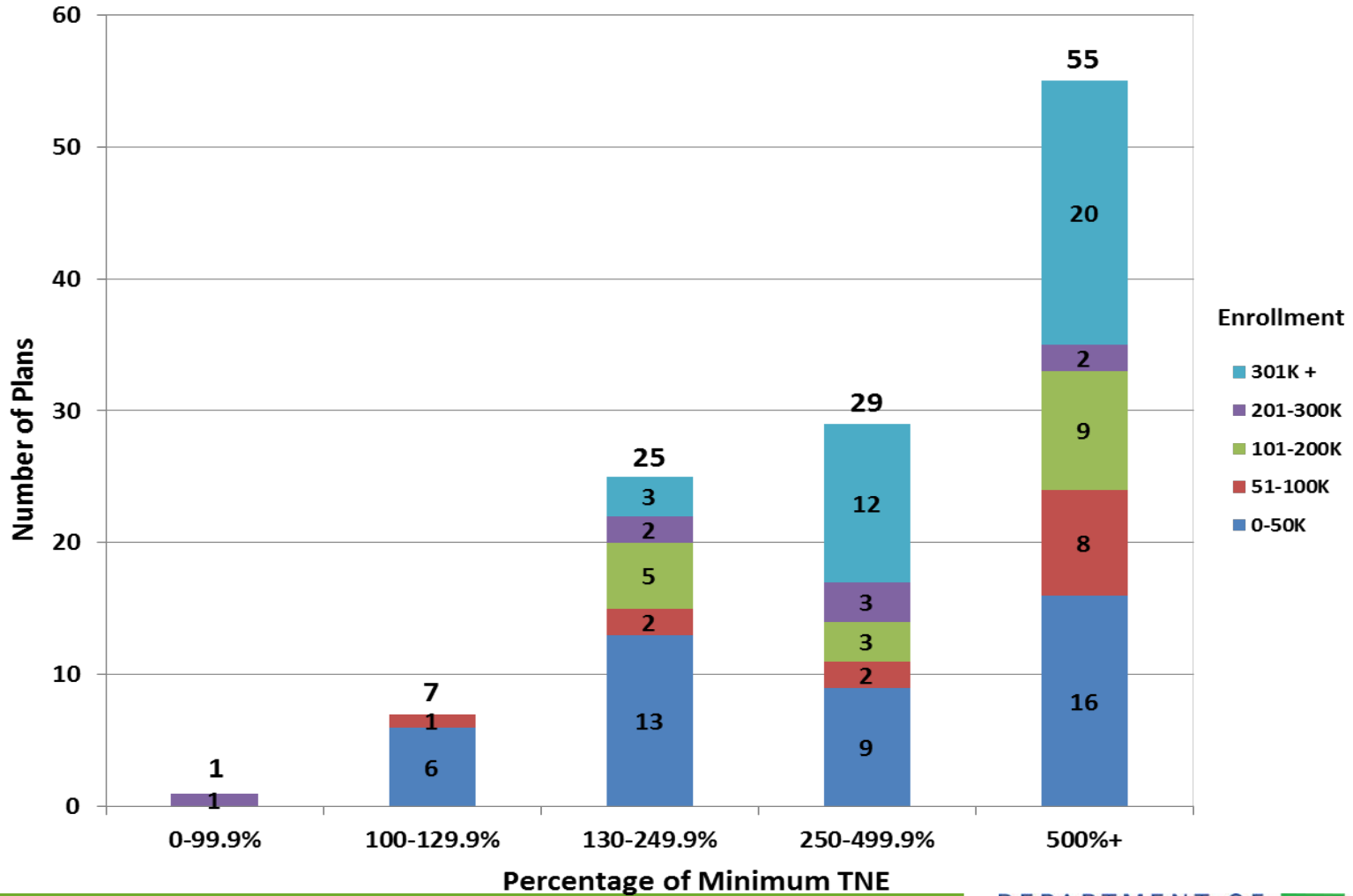

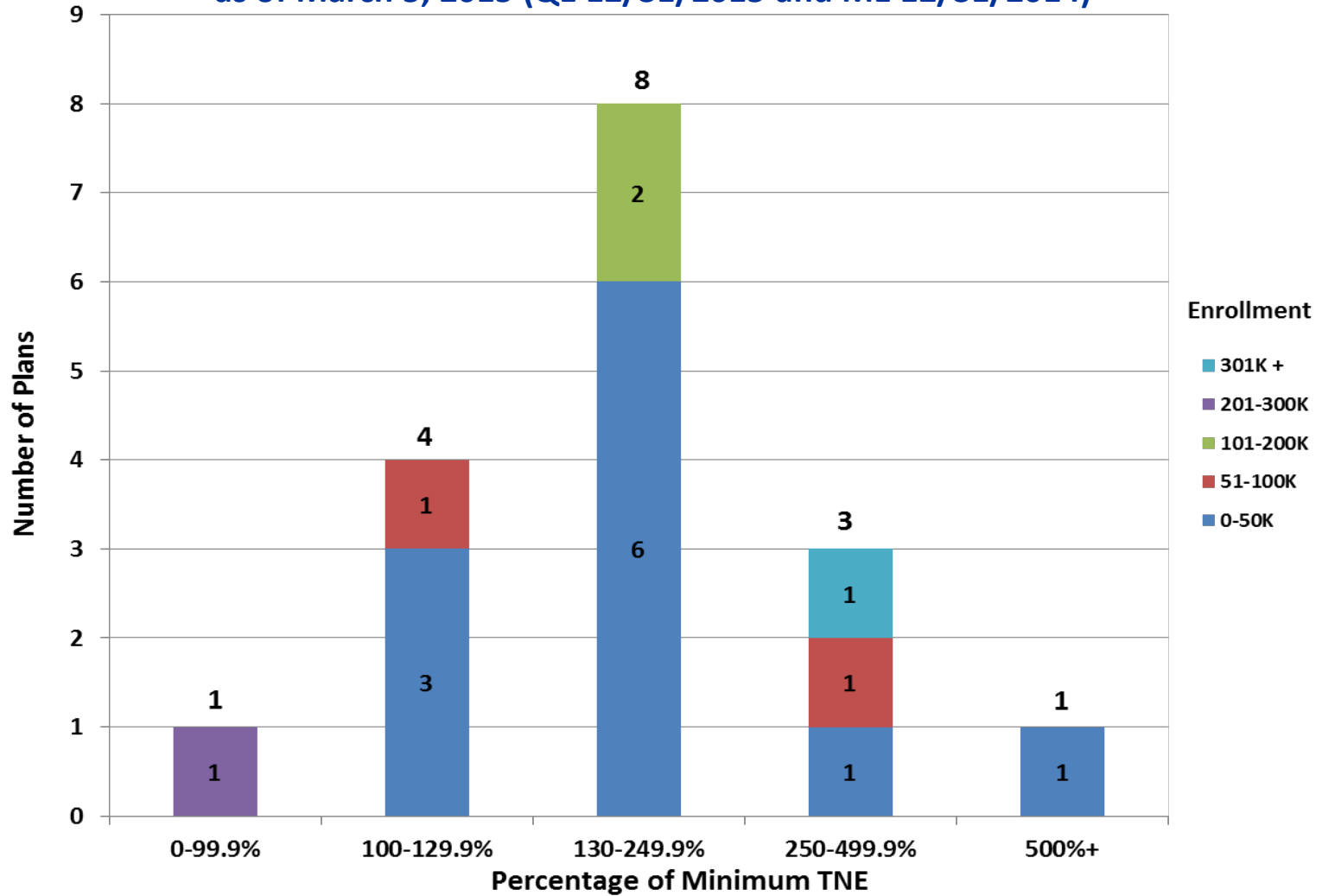
Tangible Net Equity of Plans as of December 31, 2014
