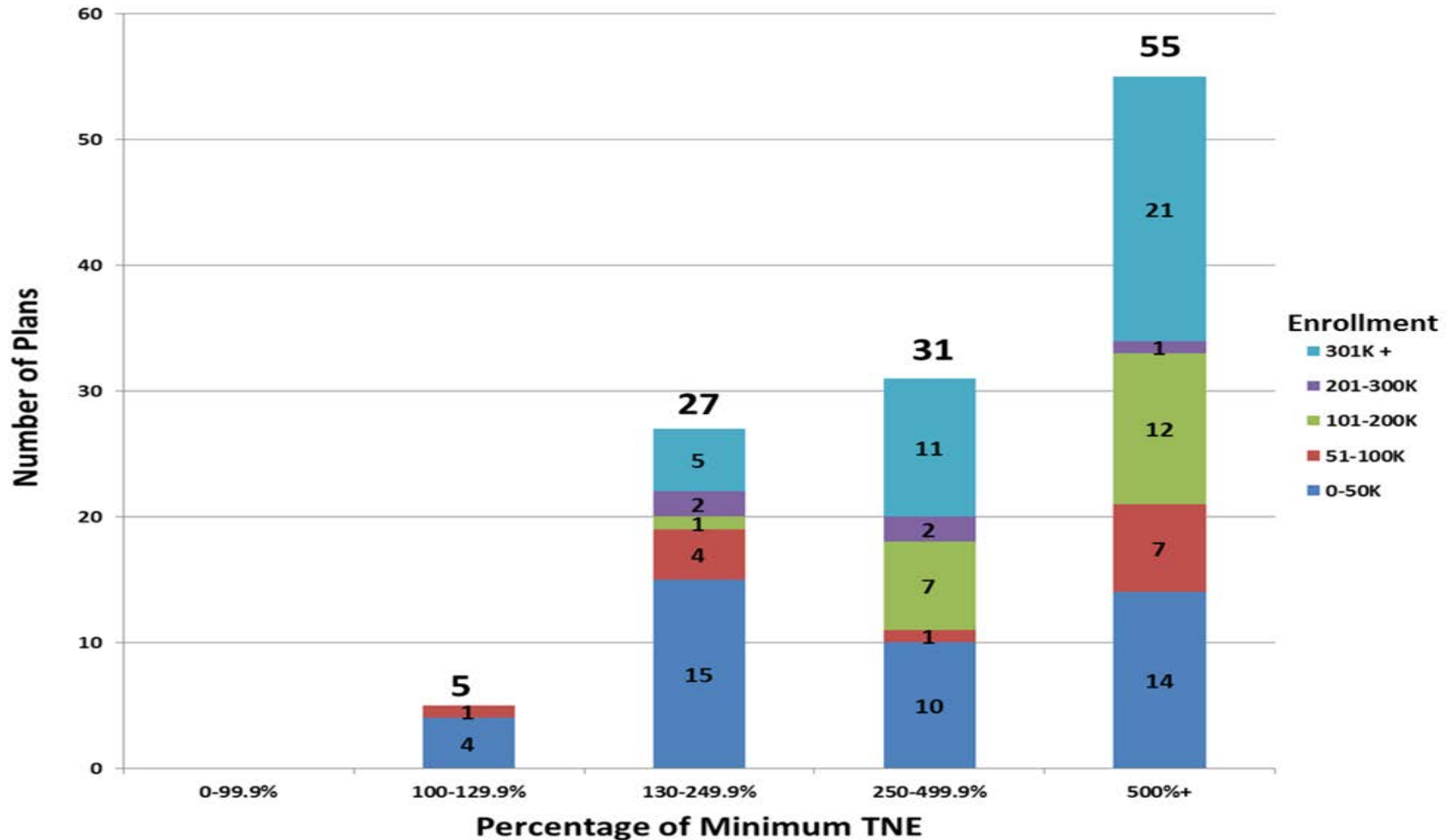

Tangible Net Equity of Plans

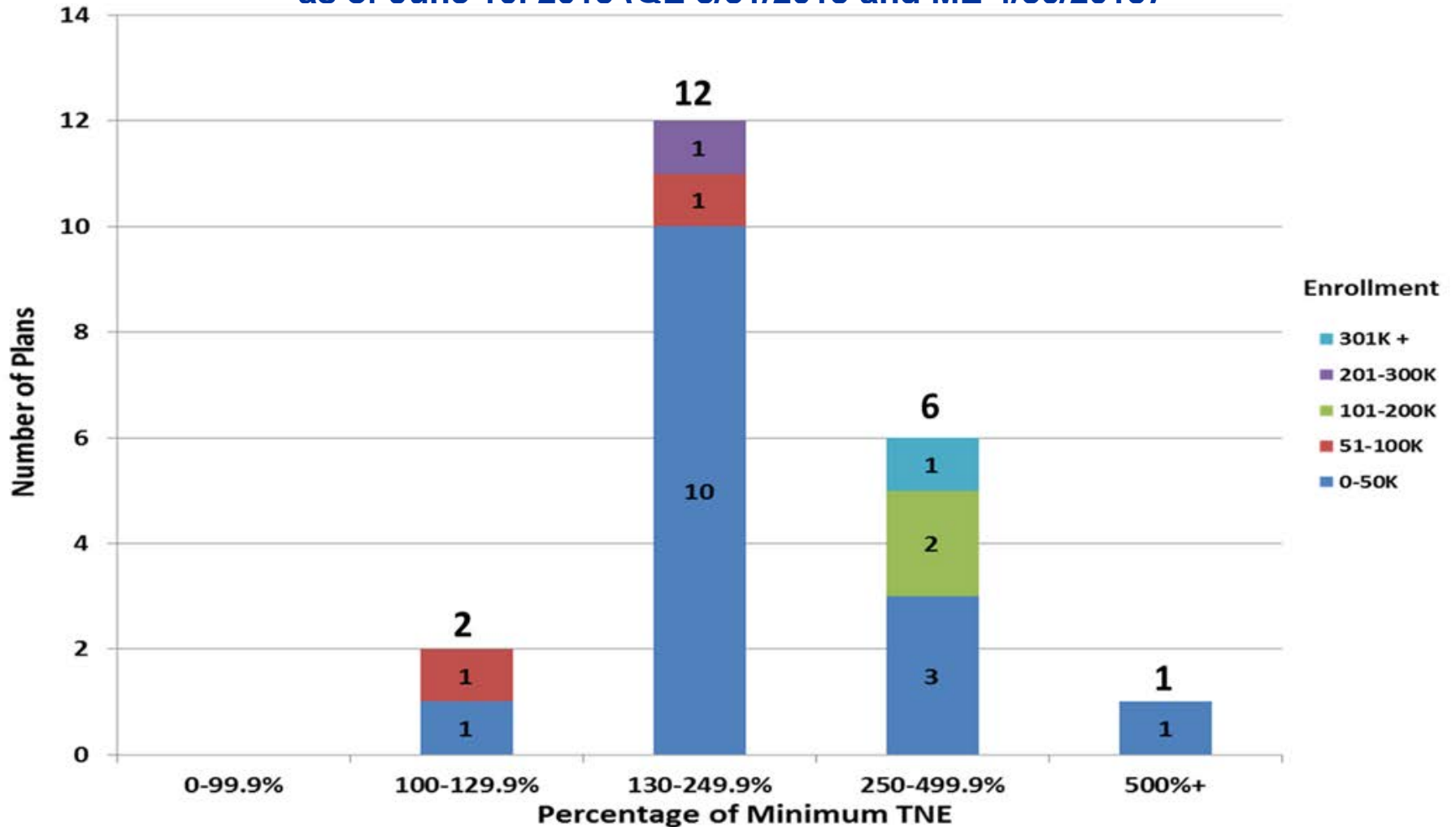
as of March 31, 2015
