**1. Welcome & Introductions**

**2. Review of January 23, 2024 Meeting Summary**

Jacob Rostovsky asked if there were any changes to the January 23, 2024, meeting summary. There were no changes.

### **3. Final Review of Training Curriculum and Quality Measure Recommendations Report**

Jacob Rostovsky gave an overview of the changes to the draft report since the January meeting and asked the Working Group for feedback on the report.

The Working Group recommended the following changes for the final report:

- The Sexual Orientation, Gender Identity, Gender Expression, and Sexual Characteristics (SOGIESC) data section should include additional language about data collection and reporting practices.
- The training curriculum section regarding reproductive health care should highlight the needs and challenges around family planning.
- The Looking Forward section should include stronger language emphasizing a “call to action”.

Director Watanabe stated the report will be reviewed and released in March 2024. Guidance to the health plans will be issued within six months after the publication of the report.
